

THE KRISPY KREME SABAN'S POWER RANGERS SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

OPEN ONLY TO ELIGIBLE LEGAL RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA, AND CANADA, AND ELIGIBLE ENTRANTS CURRENTLY RESIDING AT A PARTICIPATING MILITARY BASE LOCATION OUTSIDE OF THE 50 UNITED STATES WHO ARE AT LEAST 18 YEARS OLD OR THE AGE OF MAJORITY IN THEIR PLACE, PROVINCE OR TERRITORY OF RESIDENCE AT THE TIME OF ENTRY.

The Krispy Kreme Saban's Power Rangers Sweepstakes ("Promotion") is sponsored by Krispy Kreme Doughnut Corporation ("Sponsor"), 370 Knollwood Street, Winston-Salem, NC 27103, USA and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033, USA.

- 1. PROMOTION TIMING:** The Promotion begins on March 8, 2017 at 12:00 PM (noon) Eastern Time ("ET") and ends on April 2, 2017 at 11:59:59 PM ET ("Promotion Period"). The Administrator's computer is the Promotions' official clock.
- 2. ELIGIBILITY:** The Promotion is offered only to legal residents of the fifty (50) United States, the District of Columbia, and Canada only who are at least eighteen (18) years of age or the age of majority in their place, province or territory of residence at the time of entry. Eligible entrants who are currently residing at a participating military base location outside of the 50 United States are also eligible to participate. Employees, officers, directors, representatives, and agents of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies, and Lions Gate Entertainment Inc. (collectively, "Promotion Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All applicable federal, state, provincial, territorial, and local laws and regulations apply. Void where prohibited or restricted by law. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Eligible entrants who are currently residing at a participating military base location outside of the 50 United States may use his/her military base address as a valid physical address for purposes of entering the Promotion. Entrants will not be allowed to change their physical address or e-mail address.
- 3. HOW TO ENTER THE PROMOTION:** During the Promotion Period, an eligible entrant may visit <http://KrispyKreme.com/PowerRangersSweepstakes> ("Website") and enter his/her email address. If it is the entrant's first visit to the Website, then he/she must complete and submit the registration form by providing the information requested by Sponsor including, but not limited to: complete first and last name, street address (P.O. Boxes are not permitted), city, state/province/territory, ZIP/Postal Code,

daytime phone number, date of birth, and agree to these Official Rules. Upon subsequent visits, entrant will only need to enter his/her email address. After submitting the required information, entrant will automatically receive one (1) entry into the prize drawing.

Limit: An entrant may receive one (1) entry per day during the Promotion Period. A “day” is defined as starting at 12:00 AM (midnight) ET and ending at 11:59:59 PM ET on each calendar day during the Promotion Period, except on March 8, 2017 when the day will start at 12:00 PM (noon) ET and end at 11:59:59 PM ET. An entrant will receive no more than the stated number of entries during the Promotion Period. If more than the stated number of entries is received from the same person, telephone number and/or e-mail address on any given day during the Promotion Period, the entries may, at the Sponsor’s sole discretion, be disqualified.

IMPORTANT: If you participate via your wireless phone, message and data rates may apply. Please consult your wireless-service provider regarding its message and data pricing plans.

4. RANDOM DRAWING: On or about April 3, 2017, Administrator will select one (1) potential grand prize winner and five (5) potential runner-up prize winners from among all eligible entries received during the Promotion Period. Each winner is deemed to be a potential winner, pending verification of the entrant’s eligibility and compliance with these Official Rules as determined by Sponsor or Administrator, at their sole and absolute discretion. Canadian residents will be required to correctly answer a timed mathematical skill-testing question as further described in Section 6 before being declared a potential winner.

5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

A. Grand Prize (1): The grand prize winner will receive a trip for two (2), the winner and a guest of his/her choosing to San Francisco, California, USA (“Grand Prize”). Grand Prize includes roundtrip coach class airfare for up to two (2) people between the major commercial airport closest to winner’s residence (as determined by Sponsor in its sole discretion) and San Francisco, California, USA; three (3) days and two (2) nights hotel accommodations at a hotel selected by Sponsor in its sole discretion (single room, double occupancy); a \$30 USD pre-paid card that can be used to purchase two (2) movie tickets (specific card will be determined by Sponsor in its sole discretion); \$500 USD spending money awarded as a check made payable in winner’s name; and doughnuts for a year awarded as a \$624 USD Krispy Kreme gift card (\$12 per week for fifty two [52] weeks). The ARV of the Grand Prize is \$2,554 USD / \$3,331.86 CAD. The actual value of the Grand Prize may vary based on airfare fluctuations, if a guest accompanies the winner, and the distance between departure and destination. Any difference between the stated ARV and actual value of the Grand Prize will not be awarded.

Travel must be completed by April 2, 2018 or prize may be forfeited. Travel must be booked at least 30 days prior to scheduled travel dates or prize may be forfeited as determined by Sponsor in its sole discretion. The winner’s guest must be at least eighteen (18) years of age or be the minor child or legal ward of the winner. Guest (or if a minor, his/her parent or legal on the minor’s behalf) will be required to complete and return a Liability & Publicity Release prior to hotel booking. If winner is a Canadian resident, he/she and his/her guest must be legally able and willing to travel internationally. All hotel accommodation booking arrangements will be administered by Sponsor’s authorized designee. All travel must be booked prior to departure. Travel is subject to capacity controls, availability, weather, seasonal influences, and certain other restrictions, all of which are subject to change. No changes will be made to travel details once any element(s) of the travel arrangements have been booked, except at Sponsor’s sole discretion. No refund or compensation will be made in the event of the cancellation or delay of any flight. Travel is subject to the terms

and conditions set forth in these Official Rules and those set forth by Sponsor's travel prize supplier, as detailed in any contract issued by such supplier. If the winner elects to travel without guests, no additional compensation will be awarded.

All costs and expenses not specifically included herein are solely each winner's responsibility. The winner and his/her guest are each solely responsible for obtaining any desired or necessary travel documents (including government-issued photo identification). The winner and his/her guest hereby acknowledges that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any part of the Grand Prize. The winner and his/her guest are responsible for all in-room charges (e.g., mini-bar, movies), telephone calls, meals, beverages, gratuities, upgrades, personal incidentals, amenities and any other fees and expenses not specifically mentioned in these Official Rules. The winner will be required to provide a major credit card upon hotel check-in and all in-room charges will be charged to the credit card.

If the movie screening or any other portion of the Grand Prize is delayed, postponed, canceled or unavailable for any reason whatsoever, the winner will not be reimbursed for that portion of the prize. Tickets are awarded pursuant to a revocable, nontransferable license that is personal to the winner and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated, or otherwise conveyed. A violation of these restrictions shall revoke winner's license, and may result in the prize not being honored. Sponsor reserves the right to remove or to deny entry to any winner and/or guest if such winner and/or guest violates the previous restrictions or engages in a disruptive manner, or with intent to abuse, threaten or harass any other person at the movie screening.

B. Runner-Up Prizes (5): Each runner-up prize winner will receive a Krispy Kreme and Power Rangers prize pack that includes a hat and Power Rangers shirt, free doughnuts every month for one (1) year awarded as a \$144 USD Krispy Kreme gift card (\$12 per month for twelve [12] months), and a \$30 USD pre-paid card that can be used to purchase two (2) movie tickets (specific card will be determined by Sponsor in its sole discretion) ("Runner-Up Prize"). The ARV of each Runner-Up Prize is up to \$200 USD / \$263.20 CAD.

C. Total ARV: The total ARV of the prize available in this Promotion is \$3,554 USD / \$4,647.86 CAD*

* All currency conversions based on listed exchange rate as of February 9, 2017.

D. Odds of Winning/Limit: The odds of winning a prize depend on the number of eligible entries received during the Promotion Period. There is a limit of one (1) prize per person/household.

6. HOW TO CLAIM A PRIZE: Each potential winner will be notified via e-mail by Sponsor or its authorized designee at the e-mail address provided at the time of entry. Before being declared the winner, the potential Grand Prize winner will be required to execute an Affidavit of Eligibility/Liability & Publicity Release and tax acknowledgment ("Affidavit"), if a US resident, or a Declaration of Eligibility/Liability/Publicity Release, if a Canadian resident ("Declaration"), sent with the e-mail notification. If a potential winner is a Canadian resident, before being declared a winner, he/she will be required to correctly answer a timed mathematical skill-testing questions without assistance, which will be provided with the email notification or the prize will be forfeited. The potential Grand Prize winner must return a fully executed and notarized Affidavit/Declaration to the Sponsor or its authorized designee within ten (10) calendar days from the date it is postmarked as being sent to the potential winner or the prize may (in Sponsor's sole discretion) be forfeited. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept

the prize, or in the event that a potential winner fails to return an executed and notarized Affidavit/Declaration (where applicable), or fails to correctly complete the skill-testing question, within the ten (10) calendar day deadline, the prize may be forfeited, and in the Sponsor's sole discretion, the forfeited prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded.

WINNERS WILL BE ISSUED A FORM 1099 OR T4A, AS APPROPRIATE, FOR TAX PURPOSES IN THE AMOUNT OF THE ACTUAL RETAIL VALUE OF THE PRIZE AND MUST SUBMIT HIS OR HER SOCIAL SECURITY OR SOCIAL INSURANCE NUMBER, AS APPROPRIATE, AS REQUIRED BY LAW. ALL FEDERAL, STATE, PROVINCIAL, TERRITORIAL, AND LOCAL TAXES IMPOSED ON THE ACCEPTANCE OF THE PRIZE ARE SOLELY THE RESPONSIBILITY OF THE WINNERS.

Sponsor will attempt to mail the Runner-Up Prizes approximately 6 – 8 weeks from verification of winner's eligibility. Promotion Entities shall not be held responsible for any delays in awarding a prize for any reason.

LIMITATION OF LIABILITY:** By participating in this Promotion, entrants agree that the Promotion Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents ("Released Parties") are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Promotion; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Promotion and/or accepting a prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. Further, the Promotion Entities are not responsible for any unanswered or undeliverable winner notifications.

In no event will more than the stated number of prizes be awarded. In the event that, due to technical, typographical, mechanical or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winner. If for any reason, including but not limited to an administrative, printing, production, computer or other error or due to technical difficulties or incorrect announcements of any kind, more winning messages are distributed, or more prizes are claimed than the stated number of prizes to be awarded according to these Official Rules, the intended prizes will be awarded in a random drawing from among all verified prize claims received.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("AAA RULES"). THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR PROMOTION ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
